She moved to Atlanta, GA in 1964 and she is married to James Douglas Coleman, a native of North Carolina. Joyce previously worked as a Crime Scene Investigator for the Atlanta Police Department for 14 1/2 years and is currently employed as a Agency Clerk at Nor-

folk Southern Railroad where she has worked for the last 16 years. Joyce has been a member of Beulah Baptist

Church for 32 years.

Joyce was initiated into Capitol Star #148, Order of the Eastern Star in 1988. She served as Worthy Matron in 1995. Joyce became interested in the Daughters of Isis from her father, who was a member of Hyksos Temple in Chattanooga, TN. Over the years, she listened to countless stories from her father and countless others and that inspired her to join. Past Illustrious Commandress Judith Cates
Celebrating the Life - Cherishing the Memori

A KALEIDOSCOPE OF MEMO

Sunrise: October 12, 194 Sunset: May 1, 2013

It is an honor and privilege to pay tribute to a very special person. Judith Elaine Gates was remarkable in so many ways. Until her illness overtook her she lived her life to the fullest and touched so many people during her time here with us. She loved to read, eat sweets and drink soft drinks.

A kaleidoscope is a cylinder with <u>mirrors</u> containing loose, colored objects such as <u>beads</u> or <u>pebbles</u> and bits of glass. As the viewer looks into one end, <u>light</u> entering the other creates a colorful pattern, due to the <u>reflection</u> off of the mirrors. Let's take a walk down memory lane

through the life of Judith through a kaleidoscope. Some of us have a kaleidoscope of memories that we will always carry with us - memories that defined Judith; memories that we will always hold dear. Allow me to share some of the special memories that I have gathered from Daughters who knew Judith well - memories that personify her and her life well lived.

Paying tribute to a loved one who died is a common tradition. Tributes speak to the life the deceased person led, as well as the relationship you had with them. This tribute will take us down memory lane through part of the life of Judith Elaine Gates. Even

though we are of many different ages and have all kinds of jobs and interests, it is certain that we all have one thing in common: The Daughters of Isis, which for most of us is how we first met Judith.

Mrs. Judith Elaine Gates was the daughter of the late Mr. Richard and Mrs. Lucille Williams. She was born on October 12, 1946 in Macon, GA. She was a graduate of Ballard Hudson High School and attended Fort Valley State College and Macon Area Tech. Judy, as most of us called her, was the youngest of five children. She had one daughter, Tamiko Corbin and 2 grandchildren. Judy was a member of Beulah Missionary Baptist Church where she sang in the Senior Choir. Earlier in her professional career she worked for American Optical for 10 years, they closed and she started working for Atlanta Olympic Eye Glass Company where she ordered contact lenses and other optical supplies. She worked there for 20 years before she retired.


As I look through the kaleidoscope of her life I see the many valued and meaningful roles that Judy played. First and foremost, Judy...... the family oriented women. She loved her family and they loved her unequivocally and selflessly. According to HPC Frazier, her brothers spoiled her. Judy was a devoted mother, grandmother, daughter, aunt



and sister. She took all of these roles to heart and she strived to honor, support, guide and most importantly, love her family. She was at her happiest when she was surrounded by her family, especially her daughter, Tamiko. In talking to PC Thomas, she said that she adored her baby girl, she was crazy about her and she was all that she talked about.

As the kaleidoscope turns, I see Judy the friend. She was a good friend to so many. She could be counted on and depended on always. Whether you needed sound counsel, an empathetic ear, a shoulder to lean on or com-

panionable silence, Judy was there. When I spoke to HPC Esters I asked her what she would miss most about Judy and she said, "a true friend," Judy was someone that she could talk to about anything and did not have to worry about it not staying between the two of them. Judy was a good person to give her advice on personal issues. When I spoke to HPC White she said that "she was true to her friends and family. PC Frazier said that Judy was like one of her children and Judy called her "Mama Sarah." They had been friends over 20 years and they often traveled together and acted like mother and daughter. As I spoke to Judy's friends and fellow Daughters, I know that they will miss the friend-



ship that Judy brought into their lives.

The kaleidoscope continues to turn and I see Judy....the Sister and Past Matron of Capitol Star No. 148, Order of the Eastern Star. In talking to PC Ingram, she told me about the first time she met Judy. They were at the Eastern Star District Meeting and Judy was serving as the Worthy Matron. She opened up the District Meeting without using the ritual. PC Ingram thought that was amazing and she said to herself "if she can do it, so can I". Judy inspired her to memorize her part and she later performed the opening without using her ritual. PC Ingram has known Judy for over 12 years. When asked what she would miss most about Judy, she said "her smile, you automatically like her, love her when you see her smile." When Judy was the Worthy Matron, HPC White often travelled with her. They went to different chapter events and Judy would drive to her house and get out of the driver seat and get in the passenger seat and HPC White would have to drive so she started calling her "my Miss Daisy".

PC Esters actually met Judy in 1988 when they were waiting to be initi-

ated into the Order of the Eastern Stars. Although they were initiated into 2 different chapters they were initiated at the same time. While waiting in the social room to be imitated they started talking and discovered they had a lot in common. PC Esters said that Judy was always concerned about people and like to help people, just as she did. That first conversation developed into a friendship that lasted over 25 years until Judy's passing.

The kaleidoscope turns and bit further and I see Judy.....a member and Past Commandress of Nabbar Court No. 123, Daughters of Isis. Judy was created as a Daughter in Nabbar Court No. 123 in 1999 under the administration of Past Illustrious Commandress Mary Freeman. When I spoke to PC Stevenson about Dt. Gates she said that she was always willing to help out and she worked hard from day one. Dt. Gates served as the 1st Lt. Commandress when PC Thomas served as the Illustrious Commandress and in talking to PC Thomas about Dt. Gates one thing she remembers about her is "when she wanted something done-she did it."

Dt. Gates served in numerous positions within the Court before she was elected Illustrious Commandress. Dt. Gates was elevated to Illustrious Commandress of Nabbar Court No. 123 in December 2005 and served as the 26th Illustrious Commandress. Noble Maurice Esters served as her Noble Advisor. Her theme for the year was" A Task for every member & A member for Every Task."

Accomplishments of Nabbar Court No. 123 under Illustrious Commandress Gates reign are as follows:

- ♦ Nabbar Court was the host Court for Georgia Desert Conference/ Gala Day in May 2006
- ♦ The Equestrienne Team made their first riding appearance in the Gala Day Parade
- ◆ The Court worked jointly with the City of East Point Fire Department to host its First Health Fair that was held during Gala Day weekend
- ♦ Nabbar Court No. 123 won the Desert Queens Contest

PC Gates received her Past Illustrious Commandress Degree and became a Life Member of Nabbar Court No. 123 in August 2007. When I spoke to PC Ingram about PC Gates she said that PC Gates loved the Daughters of Isis and she loved going to Imperial Session.

The kaleidoscope turns again and I see Judy – a humble, gentle spirit. It is impossible to pay tribute to Judy without recognizing the important role that spirituality played in her life. As we have traveled today through some of the wonderful memories we have of Judy - we come to realize her quiet faith guided actions, words and deeds. 





HEALTH AWARENESS

Most Americans Should Consume Less Sodium



Most of the sodium we consume is in the form of salt, and the vast majority of sodium we consume is in processed and restaurant foods. Too much Sodium is bad for your health. It can increase your blood pressure and your risk for a heart attack and stroke. Heart disease and stroke are the leading causes of death in the United States.

In addition to excess sodium intake, other factors also influence blood pressure and the risk for heart disease and stroke. These factors include:

- ♦ Age. The prevalence of high blood pressure (hypertension) increases with age and affects more than half of people aged 55-74 years and approximately three-fourths of those aged 75 years and older.
- ♦ Family History. Having a family history of high blood pressure, including parents or close relatives with high blood pressure, may increase the likelihood that you or your children develop it also. While you can't control your family history, making healthy lifestyle choices may decrease your risk.
- ♦ Excess Body Weight. Being overweight can increase blood pressure; losing weight can help reduce blood pressure.
- ♦ Physical inactivity. The Surgeon General recommends adults engage in moderate-intensity physical activity for 2 hours and 30 minutes every week. Such activity may help reduce blood pressure.
- ♦ Inadequate Intake of Potassium, Fruits and Vegetables. Adequate consumption of naturally low sodium foods such as fruits and vegetables provide nutrients such as potassium and fiber. In eating high potassium foods such as potatoes, beans, bananas, and yogurt can help reduce blood pressure.
- ♦ Excessive Alcohol Intake. Excessive alcohol intake is associated with high blood pressure. Recommendations for alcohol intake advise moderation - no more than one drink per day for Women or two drinks per day for Men.

Current dietary guidelines for Americans recommend that adults in general should Consume more than 2,300mg or sodium per day. At the same time, consume potassium - rich foods, such as fruits and vegetables. However, if you are in the following population groups, you should consume no more than 1,500mg of sodium per day, and meet the potassium recommendation (4,700mg/day) with food.

- ♦ You are 51 years of age or older.
- ♦ You are African American.
- ♦ You have high blood pressure.
- ♦ You have diabetes.
- ♦ You have Chronic Kidney Disease.

The 1,500mg recommendation applies to about half of the U.S. population overall and the majority of adults. Nearly everyone benefits from reduced sodium consumption.
