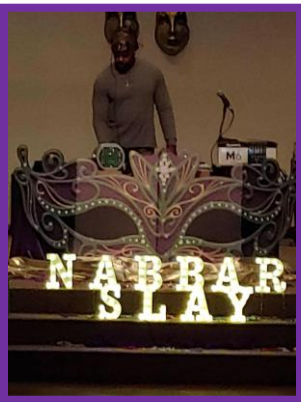

# Health & Wellness



## Community as An Anchor During COVID – 19

Life is drastically different than it was a month ago. Kids are out of school, many are working from home, sporting events and concerts are cancelled. Even movie theaters and bars are closed and dining in a restaurant is prohibited. In the wake of COVID-19, better known as novel coronavirus, changes to our usual way of life have taken a huge toll on our emotional well-being. So how do we get on with living when life is so altered? By strengthening community and making sacrifices out of love. Below you will find some guiding tips on how we can best strengthen our community - for the most vulnerable among us, and—when this is all over how we can rebound.

### Preserve the healthcare system for those who need it most

- **Don't buy more than you need.** Overstocking on critical supplies such as hand sanitizer, disinfectant wipes, and plastic gloves will make it difficult for health care providers and emergency response personnel to get what they need to take care of others. Face masks are high demand for both consumers and medical staff. Please be mindful when purchasing these items.
- **Consider whether you really need a COVID-19 test.** In an ideal state, everyone who wants a COVID-19 test should get one. Unfortunately, there is limited capacity to collect samples. At this time, testing is (and should) be prioritized for those most at risk of severe illness or who live and/or work in a high-risk setting. People with mild symptoms do not need to be tested, especially since the home treatment for COVID-19 is the same, no matter what test result comes back.
- **Limit ER use for critical health needs.** Only go to the emergency room if you are having an immediate medical emergency. For those who test positive for COVID-19, you should only go to the emergency room if you are experiencing severe symptoms, such as difficulty breathing. Less severe symptoms can be treated in the home.





# Health & Wellness

## **Social distancing but not social isolation**

Community matters now more than ever, and we need each other during these stressful times. Large events of 50 people or more are prohibited, but smaller gatherings are allowed if steps are taken to

minimize the risk of COVID-19. While social distancing will help mitigate the spread, it's still important to find ways to connect with others. Social media (Facebook, Instagram, TikTok, etc.), text messaging, or a conversation via Skype or FaceTime can ease anxiety. Even waving to neighbors while walking can make the day feel a little less lonely.

For those with children, it is important that kids still spend time with other kids. Healthy children can still get together if steps are taken to make sure they aren't sick, that they wash their hands and minimize face-to-face interaction as much as possible. Think small groups and prioritize outdoor activity as much as possible. The lower the number, the lower the risk.

## **Supporting one another**

Coronavirus is causing stress for everyone, perhaps in different ways, and we all have different coping mechanisms. But in the face of adversity, our community is coming together to support each other, and it is inspiring.

What does this community love look like? It looks like:

- Influencing your inner and outer circle with good, accurate information and resources about COVID-19.
- Sharing in childcare responsibilities, particularly to support health care workers and people who don't have work flexibility.
- Feeding our neighbors. Offer to bring someone a meal to their doorstep who may not otherwise be able to easily access healthy food right now.
- Taking care and protecting our elders. This is where staying home when you are sick and social distancing can really help save lives.
- Support local businesses. Use a food delivery service to order from local restaurants (now is the time for takeout!). Shop from local businesses online or buy gift cards to use later.

It can feel like a scary time right now. That's real. But let's acknowledge that fear and then choose to focus on ways that we can show up for each other right now. We need now more than ever to love on each other. Let's always the question, "What does love look like"? And then do that.
